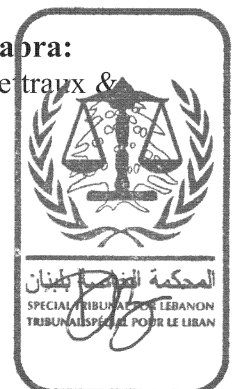

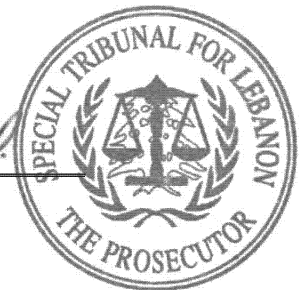
1. Pursuant to the Trial Chamber's order of 11 July 2016,<sup>1</sup> the Prosecution files an Amended Consolidated Indictment reflecting the termination of criminal proceedings against Mustafa Amine Badreddine.
2. The Amended Consolidated Indictment is annexed to this filing as Confidential Annex A. This version reflects one change from the proposed Consolidated Amended Indictment that was previously distributed to the Parties and the Trial Chamber. In paragraph 3, reference to Mr. Badreddine has been moved from sub-paragraph 3(a) to sub-paragraph 3(e), with the alleged roles of the Accused in the conspiracy reflected in paragraphs 3(a) to 3(d).
3. The other changes are the same as those in the version that was previously distributed to the Parties and the Trial Chamber. Specifically, (i) the removal of Mr. Badreddine as an accused, i.e. the removal of his name from the Counts, and (ii) the removal of bold font where his name remains in the Amended Consolidated Indictment. For ease of reference to these amendments, the Prosecution provides a track changes version of the Amended Consolidated Indictment as Confidential Annex B.
4. Finally, the Prosecution provides a Public Redacted Version of the Consolidated Amended Indictment as Annex C.
